 - b. Copies of South Kamas Irrigation Company Stock Certificates for proposed project.
 - c. Map showing the new place of use of water for proposed project.
 - d. Map and description of any retirement acreage due to proposed changes.

13. Review and Approval Process:

- a. The company engineer will date-stamp the application upon receipt and will review the plans/drawings for technical feasibility and impact to the canal.
- b. The company engineer will forward three sets of plans/drawings and his review comments the Company. The Company shall review the application pursuant to the criteria set forth in the Bylaws of the Company.
- c. If the application is approved, the Company will prepare an agreement, as set forth in the Bylaws of the Company, incorporating the plans/drawings and engineer's review comments that must be executed by the applicant.

14. Applicant understands that, as set forth in the Articles and Bylaws of the Company, the applicant shall pay all costs associated with any new diversion and to alter or repair the Company water system as necessitated by the proposed change. In addition to the application fee, the applicant shall pay any costs incurred by the Company for attorneys or engineers to review the proposed change. Applicant must be current on all Company assessments and will remain responsible for all future stock assessments. Applicant shall pay all costs and fees associated with filing the proposed Change Application with the Utah Division of Water Rights and effectuating the proposed change including the cost of filing proof, administrative costs, and costs associated with judicial proceedings.
